ALL CHILDREN MUST BE IMMUNIZED. Temple Shalom Preschool must have a copy of your child's Florida Physical and Immunization forms **ten days before their start date** for them to attend school. Medical exemptions and delays are accepted with proof of paperwork, but religious exemptions are not accepted.

Payments and Discounts

Tuition may be paid by credit card*, ACH or check beginning July 1, 2025. *Credit and Debit card service fees apply. Annual tuition will be added to your Brightwheel account, with the option to pay in **one, two, or ten installments**. **Pay in full by July 1, 2025** and receive a **10% discount** off the annual tuition. **Pay in two semester-based installments** and receive a **5% discount**.

Signed VPK voucher required to receive monthly discount. Temple Shalom members receive an annual \$500 tuition discount per child. Families with multiple children registered will receive an annual \$500 discount per family.

Tuition Payments and Late Fees

In order to maintain the high quality of the school program at the most affordable rate possible for all, the following procedures have been established.

- It is your responsibility to pay your child's tuition in full at the start of the school year or to confirm a payment plan with the Director of Admissions prior to July 1, 2025.
- If you choose to pay in **two** installments, the **first** installment will be on July 1, 2025, and the **second** installment will be on January 1, 2026.
- If you choose to pay in **ten** monthly installments, payments are due on the 1st of each month starting July 1, 2025 (or the next business day).
- All tuition payments not paid within 4 days of the due date will be subjected to a \$50.00 late payment fee.
- **By failing to pay the overdue tuition and subsequent late fees you risk relinquishing your child's placement in the program.**
- There will be a \$50.00 service charge for any checks returned for insufficient funds.

Early Withdrawal

If you choose to **un-enroll your child before the end of the school year**, please note that:

- A **30-day written notice** is required before withdrawal. Please email your notice to preschooladmissions@naplestemple.org.
- Tuition payments **must continue** during this 30-day notice period, including all scheduled installment payments if you are on a payment plan.
- Tuition is calculated on an annual basis, and enrollment is a full-year commitment. As such, payment obligations remain in effect during the notice period regardless of early withdrawal.

We appreciate your understanding and cooperation in adhering to this policy, which allows us to maintain staffing and program quality for all students.

Terms of Agreement

All tuition and fees are non-refundable (including registration). I agree to pay the full annual tuition and fees based on my child's selected schedule. **I understand and agree to the terms and requirements stated on this form.**
